WHEREAS, the North Harris County Regional Water Authority (the "Authority") is a governmental agency and body politic and corporate of the State of Texas created pursuant to Chapter 1029 (H.B. 2965), Acts of the 76th Texas Legislature 1999, amended by Chapter 1296 (H.B. 1110), Acts of the 77th Texas Legislature 2001, amended by Chapter 381 (S.B. 1725) and Chapter 248 (H.B. 1541), Acts of the 78th Texas Legislature 2003, amended by Chapter 1343 (S. B. 331), Acts of the 79th Texas Legislature 2005 and amended by H. B. 2418, Acts of the 82nd Texas Legislature 2011, and amended by H. B. 3934, Acts of the 83rd Texas Legislature 2013, (collectively referred to as the "Act"), to accomplish the purposes provided by Section 59, Article XVI, Texas Constitution; and

WHEREAS, Radcliffe Bobbitt Adams Polley PLLC ("RBAP"), general counsel and designated agent for the Authority, is the authority responsible for having the official ballot prepared for the Authority's November 8, 2022 Directors Election (the "Election"); and

WHEREAS, the filing deadline for placement on the ballot was 5:00 p.m. on August 22, 2022, and the deadline for declaration of write-in candidate for the Election was 5:00 p.m. on August 26, 2022; and

WHEREAS, pursuant to the provisions of Section 2.052, Texas Election Code, as amended, RBAP has certified in writing to the Board of Directors (the "Board") of the Authority that the candidate for Director of Single-Member Voting District No. 1 to be listed on the ballot for such Election is unopposed; only one candidate's name will appear on the ballot for that position and no candidate's name will be placed on an approved list of write-in candidates for the office of Director of Single-Member Voting District No. 1; and

WHEREAS, pursuant to the provisions of Section 2.053, Texas Election Code, as amended, the Board shall declare unopposed candidates elected to office.

NOW, THEREFORE, BE IT ORDERED BY THE BOARD OF DIRECTORS OF THE NORTH HARRIS COUNTY REGIONAL WATER AUTHORITY THAT:

<u>Section 1:</u> The Board of the Authority hereby declares the following unopposed candidate to be elected to the office of Director of Single-Member Voting District No. 1.

The candidate declared elected to office shall serve until the biennial directors election in the year 2026, or until their successors have been duly elected or appointed and have qualified.

- Section 2: The candidate declared elected to office under this Order shall enter into the duties of their office and shall begin to serve their term of office after the November 8, 2022 election date, and upon posting bond in the amount of \$10,000, taking the constitutional oath of office, and acceptance of the bond and oath of office by the Authority's Board.
- <u>Section 3:</u> Pursuant to the provisions of Section 2.053(b), Texas Election Code, as amended, the Election for Director of Single-Member Voting District No. 1 shall not be held.
- <u>Section 4:</u> The President and Secretary of the Authority's Board and Radcliffe Bobbitt Adams Polley PLLC are hereby authorized and directed to take any action necessary to carry out the provisions of this Order.
